ARI Housekeeping and Landscaping Crews

It's time to start thinking about cutting lawns, trimming bushes and planting flowers. The spring and summer months are traditionally

the busiest times for the ARI housekeeping and landscaping crews. Both begin their day promptly at 8:30am and head into the community to complete a full day of work. The housekeeping crew provides janitorial services to both businesses and private residences. The landscaping crew provides commercial and residential landscaping services including design and planting, mowing, fertilizing, debris removal, leaf removal, weeding, hedge trimming and pruning, spring and fall cleanups, and snow removal.

Other services provided are garage cleanup, dump runs, and painting. Some of the contracts include all ARI facilities, three US Post Offices, the Greenwich Weigh Station on I-95, Creative Pension Design and Administration, Photographic Memories and several private residences.

Like any private business, the ARI housekeeping and landscaping crews rely on outside contracts for jobs and employment.

From the CFO



Just as we personally experience the effects of these severe financial conditions, we here at ARI are experiencing them as well. Statewide allocations to the Department of Developmental Services' budgets continue to be slashed as legislators and the governor struggle

with deficits approaching 8 billion over the next two fiscal years. We must remind ourselves of what is at stake. State dollars enhance the lives of our most vulnerable citizens. State resources keep individuals safe in home environments such as our group homes. These resources keep individuals secure and engaged. State resources allow individuals to learn skills that transform them from tax users to taxpayers. They keep clients progressing on their life continuum through work skill training and employment building. State resources keep individuals as independent as possible through individualized home supports. We as a society must not let these fundamental supports—the ARI mission—to be altered in any way by fiscal constraints.

During these troubled times, no one really knows what is in store for the nonprofit sector. But we do know we will not sit idle while our funding is depleted.

Here are a few thoughts about our enduring goals and strategies:

- Ensuring a voice for the less powerful by joining forces. The less connected and less powerful must always have a say in the future of this sector. Well organized state associations can act to promote and create collaborative strategies that are a conduit for advocacy, public education, and even lobbying. State associations of similar nonprofits can lead this effort by providing training, aggregating concerns, and developing a clear call to action. Associations such as the Connecticut Association of Nonprofits have already proven that combined advocacy works.
- Collaboration. Nonprofits must seek new ways to collaborate with other organizations and people in their communities. It is in the give and take between unlikely partners that brilliant breakthroughs are made. Philanthropy should support but not direct these efforts.
- Enlisting the young and our stakeholders. Nonprofits must focus more on integrating young people into their leadership. We must give young people, and our clients, a voice in determining the future of the nonprofit sector.

Our staff and clients need our attention. They need our advocacy. Thank you in advance for your unwavering and continued support.

ARI Looks Back at 2008

Here are some of the accomplishments of 2008:

- All goals in the accessibility plan were met, except those requiring renovation on the Richmond Hill facility.
- All goals except one in the performance improvement plan were accomplished.
- ARI received a three-year accreditation, the highest accreditation, from CARF—The Rehabilitation Commission.
- All of our group homes have received the highest licensing available through the Department of Development Services (DDS) (two years).
- Our programs have dramatically improved reports for DDS' Quality Service Review.
- We have developed a risk management plan.
- We have formalized a marketing plan.
- We have developed a strategic plan, for which we received exemplary reviews from the CARF team.
- We revised the health and safety system and plan.
- A "Corporate Compliance System and Plan" was developed and implemented.
- The continuous quality improvement system was developed and implemented using utilization review, case

- records review, quality service review, licensing standards and CARF international standards.
- The results of our CQI report indicate that ARI continues to move forward with its person-centered philosophy and adaptation. Goals established for individuals served have been accomplished and/or addressed.
- We offered more direct service training opportunities.
- We submitted seven applications for grants and we were awarded three. The remaining four are pending.
- Activities included "Conflict at the Cove," Stamford Harbor Parade of Lights, ARI Artists Initiative Calendar, and the Men's Wearhouse Suit Drive.
- We collaborated with Friends of ARI in facilitating the Lotstein/Martin Golf Tournament, the Walk for Independence, and the Annual Appeal.
- We offered three hundred, twenty-eight recreation opportunities with over three thousand duplicated participants, two hundred, fourteen duplicated volunteers and almost eight hundred volunteer hours.
- Our board of directors volunteered one hundred, thirteen hours by attending board meetings.
