## State of the Agency

On June 9, 2016 over 50 ARI family members and friends gathered for a presentation on the “State of the Agency.” President and CEO, Susanne Kuligowski provided a detailed overview of ARI’s current programmatic and financial position – the factors that brought us to this point, and where the organization is headed.

There have been many challenges on the program side. A great deal of time and effort has been spent focusing on this. We have seen many improvements as evidenced by CT State quality service reviews and licensing inspections. However, there is a great deal more that we can do and we work to continue to improve each day.

The financial challenges have been much greater than, and have contributed to, the programmatic challenges. State funding cuts, loss of some program revenue, and increasing expenses have been very difficult to manage over the past decade. The past year has been more encouraging and we are operating much more efficiently than in prior years. We still anticipate a deficit this year, but it is significantly smaller than last year.

We have made many changes and have seen positive results. We know that there are many opportunities for ARI to take advantage of in order to continue to improve our current services as well as expand services to others in the future. We are planning for more changes to come, while at the same time we remain concerned about continued state funding cuts and other changes on the national, state and local level that can have negative impacts on our funding and program quality.

Ms. Kuligowski concluded her presentation with a reminder that what makes ARI special and unique is the importance of FAMILY:

- It’s our FOUNDATION: *ARI was founded by a group of families in 1952.*
- It’s our MISSION: *“Enriching the lives of people with disabilities and their families by enabling them to achieve their fullest potential at home, at work, and in the community.”*
- It’s our CULTURE: *In our “small” organization, everyone knows everyone. We are all (staff, consumers, family members, supporters) members of the ARI Family.*
- It’s our PASSION: *By enriching the lives of our consumers, we also enrich the lives of their family members.*
- It’s our FUTURE: *We all need to work together to ensure that the ARI family grows and prospers.*

## Recreation and Volunteers



In June, eight consumers participated in the **Special Olympics Summer Games** at Southern Connecticut State University. They competed in bicycling, swimming, and tennis. These individuals also won several medals competing with the Darien Lions Olympic Program.

Twenty consumers participate in the **Challenged People in Motion Golf Program**. This program has offered weekly golf instruction to people with disabilities for over twenty years at no cost and is 100% volunteer based. Each year participants in the program, based on ability, are able to play in the annual program golf tournament fundraiser. This year four ARI consumers played.

On July 18 and August 29, nearly 70 consumers and staff attended a **Bridgeport Bluefish** baseball game. The tickets were provided by Dot Generation, as part of the Monday Bluefish promotion.



Many of these events cannot happen without the support of the several dozen volunteers at ARI. We thank all of these volunteers who assisted with the recreation program, as well as the **21st Annual Lotstein/Martin Golf Tournament**.

## Grants and Community Support

ARI received \$7,500 from the **First County Bank Foundation** to fund the I.H.S./Residential Emergency program, which helps individuals with unforeseen expenses.

ARI received \$10,000 from **Fairfield County's Community Foundation** and \$5,000 from the **Pitney Bowes Foundation** for use in the Day Program's Life Skills and Career Development Training Program. Funds will be used to purchase computers and software to assist with life skills and employment goals for each consumer.

Thirty **Deloitte** employees, with the assistance of **HomeFront, Inc.**, painted bedrooms, stained the back deck, planted flowers and cleaned up the back yard at the Truglia Residence on Friday, June 10. This is the first time Deloitte has participated in a project at ARI, and we hope to have them back again next year.

A group from the **US Federal Support Court Program** painted hallways, planted flowers, and cleaned up the grounds at the Palermo Residence on June 22 and 29. The group included federal probation officers, attorneys, the Federal Judge, and individuals serving court mandated community service.
